LOGSDON SCHOLARSHIP FUND

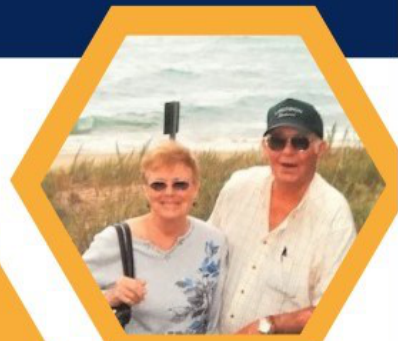
The Logsdon Scholarship Fund, created by the late Giles and Carol Logsdon, will begin taking applications March 15, 2024. Natives of Wyandot County, the Logsdons lived down the road from where Giles was born, and farmed both theirs and part of the original family farm while operating several businesses over the years. These included a wood burning stove store, first operated out of the former Harpster General Store and then from their home, an embroidery business, an orchard, and a Christmas tree farm. Carol likewise was a lifelong farmer who grew up in Eden Township.

Giles and Carol Logsdon established The Logsdon Scholarship Fund to provide scholarships annually to qualified students who have accomplished all of the following:

1. Have attended St Peter Catholic School in Upper Sandusky, Ohio;
2. Have graduated from High School; and
3. Have attended an accredited post-secondary educational institution, either academic or vocational (trade school); completing at least one year of a two or more year course of study.
